**DEED OF VARIATION OF FUNDING AGREEMENT
2026**

The Parties to this Deed are:

(1) **The Secretary of State for Education** of Sanctuary Buildings, Great Smith Street, London SW1P 3BT (the "**Secretary of State**");

- and -

(2) **Tapestry Learning Partnership**, a charitable company incorporated in England and Wales with registered company number 04544722 whose registered address is at Sherwood Rise, Nottingham Road, Nottingham, Nottinghamshire, NG7 7AR, (the "**Company**").

together referred to as the "**Parties**".

INTRODUCTION

- A. The Parties have entered into a supplemental funding agreement on 31 May 2017, a copy of which is contained in Schedule 1, (the "**Existing SFA**"); and
- B. The Parties have agreed to amend and re-state the terms of the Existing SFA on the terms set out in this Deed.

LEGAL AGREEMENT

- 1. Words, expressions and interpretations used in this Deed shall, unless the context expressly requires otherwise, have the meaning given to them in, and shall be interpreted in accordance with, the Amended Supplemental Funding Agreement (as defined in clause 2 below).
- 2. The Secretary of State and the Company agree that with effect from the date of this Deed, the Existing SFA shall be amended and re-stated in the form of the Supplemental Funding Agreement set out in Schedule 2 (the "**Amended Supplemental Funding Agreement**"). For the avoidance of doubt, the Amended Supplemental Funding Agreement does not terminate or suspend the Existing SFA but further amends and re-states it.

GOVERNING LAW AND JURISDICTION

- 3. This Deed, and any dispute or claim arising out of or in connection with it, its subject matter or formation (including non-contractual disputes or claims) shall be governed by and interpreted in accordance with the law of England and Wales.
- 4. The Parties irrevocably agree that the courts of England and Wales shall have exclusive jurisdiction to settle any dispute or claim that arises out of, or in connection with, this deed or its subject matter or formation (including non-contractual disputes or claims).

COUNTERPARTS

- 5. This Deed may be executed in any number of counterparts and by the parties to it on separate counterparts, each of which when so executed and

delivered shall be an original, but all the counterparts shall together constitute one and the same instrument.
